5. Financial review-

The association has \$31,340.98 in operating through September and \$57680.21 in reserves. Expenses are in line except for gas which is annualized and the pool supplies due to the purchase of lounge chairs. The association has collected \$15,316.26 more than they have

budgeted for the year to date.

The Associations Rentals- of units now contributes \$850(750 106) per month respectively. Expecting the other to be rented by Nov 1.Two additional rentals are forthcoming as verbal deed in lieu of foreclosures has been agreed to but not yet executed.

Review of Compliance issues- Bob Tolomeo moved that violations of the trash containers for vacant homes should include a self help policy that allows the containers to be returned to Waste Management until an owner takes possession. The motion carried unanimously.

Old Business

Pool and Financing – Based on the fact that one owner of a \$10,000 commitment decide to back out of the promissory note offer the Board agreed to allow SCPM to conduct a fair drawing of remaining interested parties at their office and contact them with a offer to participate.

Pool security lighting- After the completion of a informal study of illumination needs the Board unanimously voted for the halogen option.

Pool security cameras- Cameras should be installed the week of Oct 17th.- **Controlled access-** Todd Foley warned the Board that a certain amount of issues are to be expected as the data transferred thru many different hands. They will be corrected quickly as they are identified.
